Benefits of Industry/Academic/Association Membership:

- The membership will entail the discounted delegate fee for all IWN events during the year, up to the maximum no. of members.

Note :

- An organisation with minimal women employees, may take up the option of nominating up to 5 women for a membership fee of Rs. 20,650/- . The membership will need be taken up by the organisation as Industry Membership.

- Member having its Corporate Office/Registered Office/Establishment in a particular State from where it will be a member.
- Any company having Membership in more than one Region (multiple Membership), will pay 15% of subscription subject to a minimum of Rs 2,000/- as surcharge, per Region.

- *Membership Subscription for Industry is calculated on the basis of Gross Sales Turnover of the company for the preceding financial year.*
- *For Industry membership, if the GST figures are not submitted billing will be on 20% increase on GST of previous year.*
- *Yearly renewal subscription becomes due on 1st January.*
- *First payment : 1st & 2nd quarter (January to June) = full payment
3rd & 4th quarter (July to December) = half payment*
